

**Beattyville Waterworks**  
**Utility Agreement**

**THIS USER AGREEMENT** made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, between \_\_\_\_\_ whose address is \_\_\_\_\_, Kentucky, party of the first part, and the City of Beattyville Waterworks, party of the second part.

**WITNESSETH THAT** for and in consideration of the efforts of the party of the second part, acting through the Mayor/City Council Members, the party of the first part agrees to pay a connection deposit of \$250.00 and provide a picture ID at the time of signing this agreement to use the water system and to pay at least the minimum monthly bill thereafter regardless of whether or not the party of the first part uses the water system. If the party of the first part has been cut off due to non-payment, you will also be required to pay the minimum monthly bill until services are re-connected again. A deposit of \$250.00 is required to establish water service. Upon closure of the account, a final bill will be calculated based on usage up to the disconnection date. The final bill amount will be deducted from the deposit. Any remaining balance from the deposit will be refunded to the customer by check and mailed to the forwarding address provided. If the final bill exceeds the \$250.00 deposit, the customer will be responsible for the remaining balance.

The party of the first part agrees to permit the city to maintain, repair, remove and disconnect a service line and meter, and read meters at a point on the property to be designated by the city for each signed connection with the right of ingress and egress on property.

The party of the first part also agrees that no other person present or future source of water will be connected to any water lines served by the City's water lines.

The party of the first part also agrees that any tampering or damage to the meter by the first party will be responsible for all parts and labor to repair the meter.

The party of the first part shall maintain at his/her own expense any repairs to the service line which shall begin at the meter and extend to the dwelling or the place of use.

The party of the first part also agrees to notify the City upon their decision to sale the property in order for the City to get a final reading for the party of the first part and a forwarding address in which the final bill will be mailed to the party of the first part. Under circumstances that the City is not notified that you have moved from the property, you will be charged for services until the City is notified.

The party of the second part shall determine the allocation of water to the party of the first part in the event of a water shortage and may disconnect the party of the first part if he/she allows a connection or extension to be made of his/her service line for the purpose of supplying water to another party.

The party of the first part agrees to comply with and be bound by the Articles, by laws, rules and regulations of the city now in force, or as hereafter duly and legally supplemented, amended, or changed.

**The Utility expressly reserves the right to disconnect, confiscate unauthorized devices, and/or discontinue service or any other connection with or without notice where the Utility discovers, finds or is otherwise made aware of any such installation that poses a threat to the supply, public health or public safety.**

**The utility cannot guarantee uninterrupted service and will not be responsible for any claims arising out of the failure to deliver continuous service.**
